

Andalos Contest Rules

« Free Plane Ticket »

1. CONTEST PERIOD

For the purposes of these rules (hereinafter the “Rules”), the “Free Plane Ticket” contest (hereinafter the “Contest”) is organized by Andalos (hereinafter the “Organizer”). It will take place in Quebec from June 19, 2025, at 10:00 a.m. (Eastern Time) to September 1, 2025, at 11:59 p.m. (Eastern Time) (hereinafter the “Contest Period”).

Admissibility

- 1.** To be eligible for the Contest, an individual must:
 - a) Be 18 years of age or older;
 - b) Reside in the province of Quebec;
 - c) Have a valid email address.
- 2.** Employees, agents, and representatives of the Organizer, as well as their spouses (legal or common-law) and anyone residing with them, are excluded from the Contest.

2. HOW TO ENTER

- 2.1.** No purchase necessary.
- 2.2.** The participant must subscribe to the Organizer’s newsletter (hereinafter the “Entry”) by providing a valid email address and checking the box indicating they have read and accepted these Rules.
- 2.3.** Only one (1) entry per person is allowed. If the Organizer determines that a person has attempted to submit more than one Entry or has used more than one email address to participate, that person may be disqualified at the Organizer’s sole discretion. All such entries may be deemed ineligible.
- 2.4.** All entries are subject to verification.

3. PRIZE DESCRIPTION

- 3.1.** One (1) prize will be awarded at the end of the Contest through a random draw from all eligible entries. The prize consists of:
- a) One (1) Air Canada travel voucher with a maximum value of CA\$1,500, applicable to the purchase of a plane ticket from Canada to Lebanon.
 - b) The travel voucher is subject to Air Canada's general terms and conditions, including but not limited to flight availability, blackout dates, and voucher expiration.
 - c) The approximate retail value of the prize is CA\$1,500.
 - d) Any costs exceeding the value of the voucher—including taxes, surcharges, baggage fees, booking fees, or any other related expenses—are the sole responsibility of the winner.

4. DRAW

- 4.1.** The draw will include all eligible entries received and compiled by August 17, 2025, at 11:59 p.m. (Eastern Time).
- 4.2.** One (1) eligible entry will be randomly drawn by the Organizer from among all valid entries.
- 4.3.** The draw will take place on September 5, 2025, at 11:00 a.m. (Eastern Time).
- 4.4.** The draw will be held at the Organizer's premises, 350 Lebeau Blvd, Montreal, H4N 1R5.
- 4.5.** The odds of winning depend on the total number of eligible entries received during the Contest Period.

5. PRIZE AWARDING

- 5.1.** The Organizer will contact the selected entrant by phone and/or email within seven (7) business days following the draw to notify them of their selection. Any email notification that results in a delivery failure will result in disqualification, and a new draw will be held under the same terms.
- 5.2.** To be declared the winner, the selected entrant must, within five (5) business days of receiving the Organizer's notification:
- a) Respond to the Organizer's notification;
 - b) Complete and sign a Declaration and Release Form (hereinafter the "Declaration Form");
 - c) Correctly answer a mathematical skill-testing question;
 - d) Return the completed Declaration Form to the Organizer.

- 5.3.** The Organizer will award the prize to the winner within fifteen (15) business days of receiving the duly signed Declaration Form.
- 5.4.** The prize must be accepted as described in these Rules. It cannot be transferred or substituted, in whole or in part.
- 5.5.** All costs and expenses associated with claiming the prize are the responsibility of the winner.
- 5.6.** Failure to meet any condition outlined in these Rules or to accept the prize in accordance with the specified terms will result in automatic disqualification and forfeiture of the prize.
- 5.7.** In any such case, the Organizer reserves the right to hold a new draw among the remaining eligible entries. If a participant declines the prize, a new draw may also be held at the Organizer's discretion until a winner is declared. The same conditions will apply.

6. GENERAL CONDITIONS

- 6.1** All Entries and Declaration Forms may be subject to verification. Any incomplete, illegible, fraudulent, late, or otherwise non-compliant entry or form will be rejected.
- 6.2** The Organizer reserves the right, at its sole discretion, to require acceptable proof of identity and eligibility from any entrant. Failure to provide such proof within the required timeframe may result in disqualification.
- 6.3** All decisions of the Organizer or its representatives regarding the Contest are final and binding.
- 6.4** The Organizer reserves the right to disqualify any person who attempts to participate in a manner that is not in accordance with these Rules or is unfair to others.
- 6.5** By entering the Contest, all participants release the Organizer, its affiliates, and its advertising and promotional agencies, as well as their employees, agents, and representatives, from any liability related to participation in the Contest.
- 6.6** The winner also releases the Organizer and its affiliates from any liability related to the acceptance or use of the prize.
- 6.7** The Organizer reserves the right to cancel, modify, suspend, or terminate the Contest, in whole or in part, in the event of any issue that could affect the administration, security, fairness, or proper conduct of the Contest.

- 6.8** The Organizer is not responsible for any malfunction of computers, software, or communication lines, or for any network loss or failure that could affect participation.
- 6.9** If the Contest cannot record all entries due to a technical issue or ends early, the Organizer may, at its discretion, conduct the draw from the entries duly received up to that point.
- 6.10** The Organizer is not responsible for any damage or loss resulting from downloading internet pages or transmitting Contest information.
- 6.11** In any case, the Organizer shall not be required to award the prize other than in accordance with these Rules.
- 6.12** The winner authorizes the Organizer to use their name, place of residence, photograph, image, voice, or statements about the prize for advertising purposes, without any compensation or notice.
- 6.13** The Rules are available on the Contest website and upon request.
- 6.14** No correspondence about the Contest will be exchanged except as outlined in these Rules or initiated by the Organizer.
- 6.15** Personal information collected during the Contest is used solely for Contest administration. No commercial or unrelated communications will be sent unless expressly authorized by the participant.
- 6.16** This Contest is subject to all applicable laws and regulations.
- 6.17** If any part of these Rules is found to be illegal, unenforceable, or void, that part shall be deemed void, but the remainder shall remain in effect.
- 6.18** In case of discrepancies between the French and English versions of these Rules (if an English version exists), the French version shall prevail.
